Notes: Applicable to Flat and CSV files

- **All License Types - Zip files are no longer acceptable.**
- **All License Types - Florida will always treat the last digit of the Gallon field as a tenth (.1). The decimal is implied. You must pad this field if you use whole numbers (0) in a flat file only.**
- **Wholesaler and Blender/Retailer of Alternative Fuel - Schedule 11 is no longer valid, you *must* use the 5LO. Please follow the disbursement schedule format for the 5LO.**
- **Wholesaler and Blender/Retailer of Alternative Fuel - If you file your tax information electronically, you are not required to transfer the Schedule 5LO transaction information to the Retail Local Option Tax Worksheet (Schedule 11), the system will do it for you. The system will also transfer the total Schedule 5LO gallons to Page 5, Section II, Column A, Line 1 for you, if you have included the correct DEP facility number of the retail dealer or end-user location where the gasoline or gasohol was delivered.**
- **The DEP facility number consists of nine (9) digits. The first two (2) are the county code, followed by the seven (7) digit facility number. If your customer is not required to obtain a nine (9) digit facility number from the Department of Environmental Protection, you must insert the two (2) digit county code followed by seven 1's (e.g. Alachua = 011111111).**
- **If you do not provide the correct DEP facility number, the Department may select the county with the highest local option tax rate to assign your incomplete destination delivery transactions and a notice of additional tax due will be issued. You may also lose all of your collection allowance for failure to file a complete return.**
- **Petroleum Carrier - SCHEDULE 14A, 14B, & 14C have replaced SCHEDULES O & S.**
- **Exporter - "The import file specifications for the disbursement schedule record is not applicable to the Schedule of Exports on the Exporter Fuel Tax Return".**
- **Please refer to the receipt schedule record.**
- **Non Required Fields – Use 999999999 if a Federal Employer Identification Number (FEIN), point of origin/destination, or document number is not required. See instructions specific to your applicable license type for examples of non required fields.**

CSV File *Specifications*

WHOLESALE/IMPORTER/EXPORTER/BLENDER

The file to be imported must be in an ASCII delimited format with the appropriate fields. Each line has the fields listed below and specifies the values associated with a single location and applied period. Each field is separated with a comma and lines are terminated with a CR/LF sequence. The file can have as many lines as you like.

Note: When editing a CSV files, please preserve all leading zero(s) by using a text editor to ensure data accuracy.

In the list that follows the column labeled "FT" (for Field Type) indicates the following:

- NS Numeric - no decimal points
- NL Numeric - no decimal points
- ND Numeric - The last digit will always be processed as a tenth of a gallon.
- CS Character String
- DT Applied Period represented as a number in the form of **YYYYMM**, for example. 200810
- DT Date represented as a number in the form of **YYYYMMDD**, for example 20080608.
- C A single character
