Sign up to get e-mail notices when we post a new tax publication to our site. You can subscribe to:

- *Facts on Tax*, a quarterly publication.
- Proposed rules, notices of rule development workshops, and more.

Sales and unemployment tax filers can also subscribe to our due date reminder service. We will send an e-mail every filing period, reminding you of the next due date. Look for the “Subscribe to our tax publications” link and sign up for any or all of these. We will not share your e-mail address with any other party, except as specifically allowed or required by law.

We offer a number of electronic services, or “e-Services,” including registration and tax filing. Using advanced technology is an important part of keeping our promise to reduce the burden on those we serve. Join hundreds of thousands of taxpayers who have already signed up, and enjoy these benefits:

- **Fewer mistakes.** Many of our electronic applications check your math. This helps you avoid penalties for common errors.
- **File early, pay on the due date.** Using payment warehousing, you can submit your electronic return or report and payment before the due date. We will not withdraw the funds from your bank account until the date specified by you.
- **Immediate confirmation.** You can print the confirmation as proof of timely filing.

- **Security and privacy.** Information sent through our Internet site is encrypted and just as secure as sending a paper report and check through the mail. We use your personal information only to conduct government business with you. We will not share it with any other party except as specifically allowed or required by law. You can file and pay these taxes electronically:

- Sales and use tax
- Unemployment tax
- Solid waste and surcharge
- Communications services tax
- Gross receipts tax
- Corporate income tax
- Most fuel taxes
- Insurance premium tax
