**NEW TAXING JURISDICTION ADDED TO
COMMUNICATIONS SERVICES TAX
EFFECTIVE JANUARY 1, 2007**

Effective January 1, 2007, the following new taxing jurisdiction and its local tax rate will be added to the list of local jurisdictions for communications services tax (CST):

City Name (County name)	Local Tax Rate
Cutler Bay (Miami-Dade)	5.72%

The new jurisdiction (Cutler Bay) and its tax rate (5.72%) are effective for all bills issued on or after January 1, 2007, regardless of the date that the service is rendered or transacted. This rate will stay in effect until further notice by the Department.

Cutler Bay will be added to the CST return (Form DR-700016; Schedule I, Column A) in alphabetical order within Miami-Dade County, changing the order of the jurisdictions within that county. See below for the new order of Column A within Miami-Dade County.

If you file using our Internet website, you will be able to select and add Cutler Bay when you file your January 2007 reporting period return.

If you file using electronic data interchange, you should add the code ZCUT in your file to represent Cutler Bay when you transmit your January 2007 return.

The FIPS code the department will use within the Address/Jurisdiction Database for Cutler Bay is 15975.
